Sponsor Flag Dedications, Patriots Celebration Seats, Logo, and Program Ad Requirements and Deadlines

FLAG DEDICATIONS

Sponsors must provide flag dedications (Individual and Adopt-a-Hero) on the enclosed form as soon as possible, but no later than **October 15, 2020**. Sponsors can designate any or all of their flags to the “Adopt-a-Hero” program by choosing the Hero by choosing the branch or type of service on the form. The dedication message will be attributed to that sponsor. *Note: Sponsor flags not dedicated by October 15, 2020 will be designated as “Adopt-a-Hero” flags. The sponsor will be acknowledged on the dedication tag.*

PATRIOTS CELEBRATION SEATS

Sponsors must provide Patriots Celebration guest names as soon as possible, but no later than **November 1, 2020**. Sponsors have the option to assign any unused Patriots Ball seats or tables to Fallen Military and/or First Responder families, or seats/table for Hero Tables. The event committee will gladly extend the invitation to leaders of the selected organization to select attendees (such as Blue and Gold Star Moms, police/fire/sheriff chiefs, Fort Hood or Camp Mabry brass, EMT/EMS chiefs, etc.).

LOGOS AND AD ARTWORK

Camera ready artwork that meet the resolution and format requirements for logos and program advertisements must be provided by the sponsor. Logos must be submitted immediately to ensure placement on Website. Ad artwork is requested as soon as possible, but no later than **October 7, 2020** to be in the program. Sponsor logos will be added to the websites as soon as they are made available in the required format and resolution.

Sponsor logos will be printed on promotional materials as made available by printing runs. The logo or name will be added in the next run of materials if received after a printing run (unless it is the last print run). Logos submitted after the last printing deadline cannot be included.

ARTWORK REQUIREMENTS

Logos must be in high resolution, no less than 300 dpi at 4 x 5 inch usage size for ads, and 8 x 10 inch usage size for sponsor banner, in jpeg format -or- vector-based art, all fonts converted to path in pdf format.

It is recommended that your advertisement have a patriotic theme that honors military, first responders, and/or COVID-19 Heroes.

Dear Applicant:

Our letter of the above date stated that we had determined your organization is exempt under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3) and that you would be treated as a publicly supported organization and not as a private foundation during your advance ruling period. This was based on our determination that you could reasonably be expected to be an organization described in sections 170(b)(1)(A)(vi) and 509(a)(1) or in section 509(a)(2).

We also stated that at the end of your advance ruling period you would have to establish that you were in fact an organization described in one of the above sections.

Our records indicate that your advance ruling period begins and ends on the dates shown above. Your exempt status as an organization described in section 501(c)(3) is still in effect. However, to establish that you are a publicly supported organization described in sections 170(b)(1)(A)(vi) and 509(a)(1) or in section 509(a)(2), please complete the attached Form 8734, Support Schedule for Advance Ruling Period, for each of the tax years in your advance ruling period.

The information requested in this letter is required to support your claim to be other than a private foundation. It is needed in addition to any required Form 990 or other annual return. Please send it to us within 90 days from the end of your advance ruling period.

If we do not receive this information, we will presume you are a private foundation and you will be treated as a private foundation as of the first day of your first tax year for purposes of sections 507(d) and 4940 of the Code. In addition, if you do not provide the information by the time requested, it will be considered by the Internal Revenue Service that you have not taken all reasonable steps to secure the determination you requested.
